SINCE OUR FOUNDING IN 1897, OUR PROGRAMMING AND SERVICES AT HEPHZIBAH HOME HAVE GROWN AND EXPANDED TO FURTHER MEET THE NEEDS OF THE FAMILIES WE SERVE. WE HAVE INTRODUCED THERAPEUTIC TEAMS, BEHAVIOR ANALYSTS AND INTERVENTIONISTS, ALONG WITH OUR RESIDENTIAL COUNSELORS TO PROVIDE THE BEST CARE FOR OUR CHILDREN.
